


# Are there any data conscious products?

## Take aways

- It is hard to make the perfect ethical decisions, but:
  - > We can control what kind of data we want to gather and share
  - We can be transparent with our users
    when we're tracking them for specific purposes



## Take aways

- we should not share any personal data if not strictly necessary
